**Customers registering vehicles covered by a commercial policy were asked to complete a Commercial Insurance Notification form (REG 5085) and provide proof of insurance at registration. The completion and filing of form REG 5085 is the insured's responsibility, not the carrier's. Thus, "voluntarily" means on an account by account basis, where the underwriter agrees to do so for selected insured, not across the board for all Chartis commercial automobile policies written

***At the time of the vehicle registration and/or policy renewal (if the policy number changes), the insured is responsible for providing their auto ID card to the DMV, or they can go onto the NV DMV website, (www.dmvnv.com) and using the 'Insurance Policy Update' link to update insurance. The carrier does not need to get involved unless the coverage that was entered in the system does not confirm. Nevada DMV now has real time inquiry access into the carrier's Electronic Data Warehouse (EDW), where they can immediately verify coverage.

Definition: Online Verification (OLV) - State DMV has access to Carrier's Policy Database to verify Proof of Insurance.

- Key Notes:
1. Composite Rated Policies: Can be reported as non-vehicle specific transaction (policy level, no VIN required)
 2. Except for states that require ONLY vehicle specific reporting – DC (policy cancellation/non-renewals only), GA, KS, KY(policy cancellation/non-renewals only), MA, NY & NC
 3. If vehicles are leased, they MUST be reported as vehicle specific transactions for all states
 4. All the reporting data elements MUST match the vehicle registration including name, address, VIN, FEIN, etc.
 5. Vehicle reporting should be completed to the state where the vehicle is registered, not where it is garaged.
 6. When reporting non-vehicle specific, it MUST include all the variations of different registrant name, address, FEIN etc. For example, for the state of NM a registrant name with ABC INC is different from a registrant name with ABC-INC.
